Narrative/Case Notes*Reported:* 07/22/2019 04:15*Reported By* P. Green

Narrative: On 07/22/2019 at 04:15 hours, Officer P. Green (2191) responded to threatening phone calls at 7128 Kingston Pike, at IHOP. Upon arrival, officers spoke to the employees, who stated that someone posing as KCSO detectives had called them multiple times inquiring about money amounts on hand as well as banking information. The suspects stated that the IHOP was under fraud investigations and attempted to coerce employees into putting money on a Green Dot card to be electronically sent. While these are common phone scams this one stands out due to the fact that the suspects were able to make the caller ID appear to be the KCSO number. They also presented a fake name of detective "Christopher Lane" badge 4426 and a separate badge number of 7616. The suspects called from 828 (518-0307) before calling back from the cloned KCSO number. The employees felt compelled to call due to the knowledge that the suspects had of them. Officers advised the victims that we do not ever request banking information or money over the phone.
